PROJECT OVERVIEW

Inequality has been growing within and between European countries. Welfare and public policies in Europe are intended to promote more inclusive growth.

The EU-funded GI-NI project aims to improve our understanding of the changes and the joint impact of three major transformations on inequality and inclusive growth: technological progress, globalisation and migration.

The outcomes of these three transformations are difficult to predict, but we can clearly see that that these changes, while beneficial to some individuals, are detrimental to others.

GI-NI OBJECTIVES:

- Measure impacts of the transformations on work, skills, and inequality.
- Synthesize and analyse their interaction.
- Foster dialogue and co-create future options with stakeholders.
- Collect and consolidate data and produce future projections.
- Identify policy and governance options for inclusion and equality.

GI-NI OUTCOMES:

- New scientific understanding of joint impacts of transformations.
- Multilateral policy solutions.
- New evidence in support of a robust EU policy strategy.

- Alexandra Spitz-Öner is a Professor of Economics at the Department of Business and Economics at Humboldt-Universität zu Berlin, Germany, a research associate at the Institute for Employment Research (IAB) in Nuremberg, and the Deputy Director of the ROOKWOOL Foundation Berlin Institute for the Economy and the Future of Work (RF Berlin). In addition, she is a principal investigator of the Collaborative Research Center/TransRegio "Rationality and Competition", funded by the German Sciences Foundation.
- Her research interests are in Applied Microeconomics, in particular Labor
 Economics. Her research focuses on understanding the challenges for workers
 brought about by technological changes, trade and migrations.




